ORDER:-

Government of India vide references 1st and 3rd read above, has issued notification for additional potential area of 3,29,665 hectares (8,14,272 Acres) in (25) districts of Telangana apart from already identified existing districts for area expansion of oil palm.

2. Accordingly, Government has allotted the Factory zone of newly identified 25 districts of Telangana State as per the potential area notified by the Government of India to the companies/firms/Co-operatives to take up oil palm cultivation/area expansion and for establishment of Oil Palm Processing Units in the territorial jurisdiction of the respective area.

3. Government have decided to take up the following steps to promote Oil Palm Plantation in Telangana State :

- a. Promotion of Oil Palm Plantation in 20 lakhs acres in the three years from 2022-2023
- b. Subsidy pattern of Rs.26000, Rs.5000 and Rs.5000 per acre in the first, second and third year of plantation.
- c. Utilization of the resources with Forest Department, Forest Development Corporation and with Panchayat Raj and Rural Development Department to raise nurseries.
- d. Deputation of a study team to Costa-Rica, Malayasia, Thailand and Indonesia to study the crop and its ecosystem comprising of Hon'ble Ministers, Peoples' Representatives and officials.
- e. Extending incentives under IDEA and TS SFPZ to the Oil palm processing units.

4. Government also constitute a Cabinet Sub-Committee headed by the Hon'ble Minister for Agriculture and consisting of Hon'ble Minister for Finance and Hon'ble Minister for Industries to decide the policy and implementation strategies for promotion of Oil Palm plantations in the State.
